

As was discussed at the recent Joint CCGA National Council Meeting in Milwaukee, Wisconsin, clarification is required on the identification of CCGA vessels, more specifically with respect to three items that are protected under the Trademarks Act.

The three items used inappropriately by the CCGA are:

- The Canada wordmark, which is the word Canada with the small Canadian flag over the last
 "A":
- 2. The white stripe slanting from fore to aft; and
- 3. The words Coast Guard, Garde cotiere.

As was agreed at the National Council Meeting, Frank Hudson and Robert Petipas have volunteered to develop a National Identification Scheme for CCGA vessels that all CCGA vessels can adopt. It is hoped that this new National Identification Scheme will be developed in the very near future for implementation in early 2003. Once a National Identification Scheme for CCGA vessels has been agreed upon by the members of the National Council, then the vessels can be remarked.

In the meantime, to avoid confusing members of the public and other SAR agencies, etc., the above noted three items should be removed from all CCGA vessels prior to the 2003 boating season.

It is understood that in all likelihood the words Coast Guard Auxiliary/Gardecotiere auxiliaire will be included in the new National Identification Scheme. However, every effort should be made to ensure that the vessel is clearly identified as a Coast Guard Auxiliary vessel and cannot be mistaken for a Coast Guard vessel.

For those regions requiring immediate modification of their existing paint schemes, they should contact their regional Coast Guard representative responsible for CCGA operations for assistance. For CCG vessels where ownership has been transferred to the CCGA it is recommended that Coast Guard give support in the re-marking of these vessels.

Training Courses



The traditional SAR 1 and 2 courses have been phased out by CCG. In their place, will be a SAR Seamanship course and a SAR course. This means that all SAR material in both SAR 1 & 2 courses will be amalgamated into one course. This would include topics such as search areas, search patterns, search procedures and personal safety. Seamanship topics would include Standard operating Guidelines, Towing procedures and any other seamanship knowledge useful in SAR operations.

It is hoped to have these courses in place by mid 2003. New members will likely be expected to take both courses. Existing members may qualify for "grandfathering". Although these standards have not been set, I would expect that members who have had courses in recent years and / or have had SAR taskings / on water exercises would likely qualify.

The reasons for these changes in training is that, in the first instance, there is a very wide range in the level of training between SAR crews and the second instance, a potentially serious liability issue exists if CCG tasks crews who do not meet some basic standard. The fact is that the CCGA has operational vessels in various districts with absolutely no SAR training. In other instances, crews may only have SAR 1. Within a short while, all crews will meet minimum "check off" standards.

I am quite sure that some "seasoned mariners" may find these changes a little tough, but I would hope that, if for no other reason than the betterment of the organization, we all work toward a proven level of SAR competence.

AND THE SHIP'S BELL TOLLED ...

During the Canadian Coast Guard Security Patrols in early fall, a Memorial Service was held on board the C.C.G.S. SAMUEL RISLEY on Monday, September 16th, 2002, upon the waters of Lake Superior. The Memorial Service was for the men on board the Canadian Government Lighthouse Supply and Bouy vessel LAMBTON that went missing, with a loss of twenty-two lives, in April of 1922.

The steel-hulled LAMBTON, built at the Canadian Government Shipyard at Sorel, Quebec in 1909 was 108.0 feet in length, 25.1 feet in beam, and 12.7 feet in depth.

During the shipping season of 1921 the Sault Canadian Canal remained open until December 15, waiting for the LAMBTON to lock through, with the lightkeepers and assistants on board, from Lake Superior. Due to the lateness of the season and heavy ice the LAMBTON was unable to reach her home port of Parry Sound and wintered at Sault Ste. Marie, Ontario.

The LAMBTON left the Canadian Sault at 1030 (10:30 a.m.), Tuesday April 18, 1922, with lightkeepers, assistants and supplies for the upcoming navigation season and sailed into Whitefish Bay. Light ice was reported in Lake Superior and upbound vessels expected no trouble. A severe wind storm, out of the northwest, struck the Sault on Wednesday, April 19, 1922, at 2030 (8:30 p.m.).

The steamer GLENFINNAN reported she last saw the "LAMBTON at 1400 (2 p.m.) on April 19, forty miles out from Whitefish Point heading for Caribou Island." On April 23 at 0630 (6:30 a.m.) the downbound Canadian steamer VALCARTIER reported sighting wreckage "about 25 miles southeast of Michipicoten Island and 15 miles east of Caribou Island." Neither the LAMBTON or any of the souls on board were ever seen again.

The Memorial Service was held at 47° 24.222' N and 085° 37.795' W - 18.5 miles south of Michipicoten Island and 8.44 miles northeast of Caribou Island RACON.

Captain Paul Beasley of the C.C.G.S. SAMUEL RISLEY had ordered the ship stopped and the memorial service began at 0055 (12:55 a.m.).

"We are gathered here tonight to remember the names and honour the memory of the Captain, crew, lighthouse keepers and assistants, who on board the Canadian Government Lighthouse Supply and Bouy vessel LAMBTON, gave their lives in the performance of their duties.

Lost upon these waters in April 1922, your supreme sacrifice will not be forgotten. To this, the men and women of the Canadian Coast Guard and the Canadian Coast Guard Auxiliary toll the ships bell, in your honour."

After the reading of each name, the Ship's bell tolled.... Twenty two times, once for the Captain and crew as well as the Lightkeepers and Assistants.

The SAILOR'S PSALM was read.

"They that go down to the sea in ships and occupy their business in great waters; these men see the works of the Lord and his wonders in the deep. For at His word the stormy wind ariseth which lifeth up the waves thereof. They are carried up to heaven and down again to the deep; their soul melteth away because of the trouble. They reel to and fro, and stagger like a drunken man, and are at their wits' end.

So when they cry unto the Lord in their trouble. He delivereth them out of their distress. For he maketh the storm to cease so that the waves thereof are still. Then are they glad because they are at rest; and so He bringeth them unto the haven where they would be."

Psalm 107, verses 23 to 30

A bouquet of twenty-two Carnations, one for each person on board, was placed upon the water by Captain Paul Beasley of the C.C.G.S SAMUEL RISLEY. After the heart-felt Memorial Service a moment of respectful silence was observed.

Editors Note:

The name board from the LAMBTON was removed in 1921 to be painted and secured back on the vessel, upon her return. The LAMBTON never made it back to her home port and the unpainted name board may be seen at the Parry Sound Canadian Coast Guard Base. Most of the crew, on board the LAMBTON, were from Parry Sound and Sault Ste. Marie. Both towns were devastated by the loss. In an ironic twist of fate Laverne Kaebisch and Stanley M. Liddle, both from Sault Ste. Marie, were not members of the crew, but the Boys' Naval Brigade, which was formed in 1920. The Boys' Naval Brigade was the forerunner of the Royal Canadian Sea Cadet Corps Royal Sovereign.

We were having a rendezvous at the Port of Orillia with Richmond Hill and Newmarket Power Squadron – it was a beautiful weekend and we had just enjoyed a delicious pancake breakfast when a gentleman by the name of Duff Dwyer approached us and asked if he could have a few minutes of our time. He talked- we listened (that's the way it is with Duff). Somehow, in his 10 minute spiel, he convinced 6 of us that the Canadian Coat Guard Auxiliary was a great organization and with our CPS background we were naturals. So... we said sure, why not and the rest is history. That was back in 1998. Our training was completed in January 1999 and we became (silently) the first CCGA inland water group in Canada. Our activities consist of PCCC's, presentations and displays only. Now 6 people cannot cover much ground so as we attended boat shows etc. to spread the boating safety word, other people started asking questions and so we grew. In 2001 I was asked to take on the responsibilities of District Co-ordinator, which I did. Henceforth we needed more volunteers. By 2002, we are 34 members strong with more members waiting to join.

Our season begins with our District Meeting in March. This is the time to go over any new regulations, discuss any problems we had with PCCC's or shows etc. This is also when we get out our marina book and start planning our strategies for the summer. Our work begins on the long weekend in may and we average at least 2 or 3 marinas every weekend, sometimes more. We also cover 4 major boat shows in Orillia, Barrie, Gravenhurst, Poker Run in Penetang, Fishing Derbies in Kincardine and Owen Sound. We also assist CCG at Toronto Boat Show, Sportsman Show, and Cottage Life Show.

In 2002 we attended 5 events/presentations, at least 18 marinas and 6 shows.



Fave Sinclair Office of Boating Safety

For the year 2002, the Office of Boating Safety (OBS) had to manage its operations and strive to uphold the same levels of service to clients while operating under budget cutbacks. Despite the funding pressures, the Boating Safety Specialist (BSS) Program remained a top priority and strong component of the Canadian Coast Guard, Office of Boating Safety program. We continued to book and track events that were attended by the Auxiliary and other BSS partners, distribute boating safety promotional and printed material and conduct a limited number of training sessions.

For the 2003 season, we anticipate offering the new "Train the Trainer" session to CGA Boating Safety Specialists. This course will allow qualified CGA members to teach the OBS 1, Pleasure Craft Courtesy Check course to other Auxiliary members, either as a refresher course or as a course to new recruits. Dates are to be announced.

One of the areas most affected by the budget reduction where we are not able to maintain the same level of service is the Boat Show Program. In the past, OBS attended all major boat shows located within our region. However, for 2003, the only boat show that we are able to attend is the Toronto International Boat Show (January 11-20, 2003) which is being financially supported by the Ottawa OBS office. OBS C&A is, as always, looking forward to working with Coast Guard Auxiliary for this show. A staffing grid was distributed during the last week of November to DBSC's in districts 1, 2, 3

and 4. Members in these districts who had an interest in working the show were asked to contact their designated DBSC, who in turn, were to contact Greg Meaker of the OBS. The Edmonton boat show also has been confirmed as a booking for the CGA. The contacts for this show are Jack Kruger (CGA District 9) and Ian Salisbury (CG). If other opportunities arise for us to attend additional boat shows, we will look forward to CGA participation at these shows as well. If further shows are added to the roster, we will distribute staffing grids with dates and locations to DBSCs, who will, in turn, notify the CGA members.

We look forward to another year and thank you for your continued support and participation in the program.

COAST GUARD STRETCHED TOO THIN: OPPOSITION COMMITTEE WebPosted Thu Oct 31 07:34:02 2002

ST. JOHN'S--Funding for Canada's coast guard has been slashed so deeply it can no longer fulfill its mandate of search and rescue and environmental response, said a committee of opposition senators and MPs.

The group, which also includes members of the transportation workers union, examined coast guard resources across the country. They're expected to call on Ottawa Thursday to hold a public inquiry into coast guard funding. The coast guard has struggled to operate since it was taken over by the Dept. of Fisheries and Oceans, said committee member Senator Pat Carney.

The cuts have been so severe that at times only 20 per cent of the waters off the West Coast are covered by radar, said Carney. Coast guard workers on the East Coast are also worried, said Newfoundland Tory MP Loyola Sullivan.

"All of them will express concerns about tightening up the financial side of it and the cutbacks that result because of it," said Sullivan. He said a ship used as an ice breaker and patrol vessel sold last year has yet to be replaced.

Public safety net eroded: Carney Carney said a public inquiry is necessary.
