

### A Message from the CEO

**Setting Priorities for Challenging Times** 

n recent years, the Canadian Coast Guard Auxiliary has experienced a sizeable increase in membership, training, SAR operations and safe boating activities.

Through our Contribution Agreement with the Canadian Coast Guard and through our fundraising efforts, we have obtained increases in funding that roughly matched our expanding activities. Additional funding would certainly allow us to do even more, but the current level of funding allows us to fulfill our mission.

Looking ahead however, we are very concerned about the future. The level of funding from the Canadian Coast Guard is expected to be stable over the next four years. At the same time, we are facing significant increases in basic expenditures such as insurance premiums and fuel.

To make matters worse, the Auxiliary is being asked to expand SAR services in geographic locations such as the Labrador Coast and the Canadian Arctic. The Office of Boating Safety has also asked the CCGA to take over some prevention programs. So far, these expensive requests have been made without any offer to increase our funding accordingly.

The initial expansion of the CCGA in the Arctic was mostly financed through a New SAR Initiative project funded by the National Search and Rescue Secretariat. Funding for this three-year project is coming to an end in 2003.

In 2002, we were able to compensate for the sizeable increase of our insurance premiums by using the reserve which is kept in Ottawa to cover unanticipated costs for SAR operations. The CCGA regional associations were spared from using a portion of their budget allocation to cover these increases.

# 25 Years of Life Saving

#### Something to Celebrate

n August 9, 1978, the Canadian Marine Rescue Auxiliary (CMRA) was formed and consisted of some 700 members and 300 vessels. Over the last 25 years, CMRA evolved into the Canadian Coast Guard Auxiliary and has grown to nearly 5000 members and 1500 vessels. This year, the CCGA celebrates its Silver Jubilee and 25 years of providing exemplary search and rescue and boating safety services across Canada.

2003 marks an important milestone for the CCGA. In acknowledgement of the anniversary, various national and regional celebrations have been planned.

The Central & Arctic Region will host the National Silver Jubilee celebrations at Fort Henry in Kingston, Ontario on August 9, 2003, 25 years to the day since the creation of the CMRA. The event will include a regional SAR competition at the HMSC Cataraqui, an awards ceremony, a reception and a world famous sunset ceremony at the Fort Henry Historic Site. Representatives of the Canadian Coast Guard, the Canadian Department of Fisheries and Oceans, the United States Coast Guard Auxiliary and other organisations involved in maritime safety will be invited to attend.

The Quebec region will celebrate the 25th anniversary during their Regional SAR Competition to be held September 5th and 6th, 2003 at the Coast Guard Base in Sorel, Quebec. The event will also mark the official opening of CCGA-Quebec's new headquarters. Activities for CCGA members, special guests and the general public have been planned.

The Newfoundland region will recognise the 25th Anniversary during the International SAR Skills Competition (ISAR 2003) that will be held in St. John's on September 26th and 27th, 2003. During the event, CCGA Newfoundland volunteers who have provided 25 years of service to maritime safety will be honoured and the accomplishments of the last quarter century will be celebrated.

During the first week of May, the Maritimes Region is attending an Emergency Measures Organization ceremony at the Joint Operations Centre in Halifax. There, the Honourable Jamie Muir, Minister of Justice for Nova Scotia will unveil a plaque on the "Wall of Honour" in recognition of the service provided by CCGA members. Various other events will be held throughout the year in honour of the Silver Jubilee.

In the Pacific region, they have defined the goal of their Silver Jubilee celebration to be interaction between all levels of CCGA-Pacific. Towards this aim, events are being planned that will bring together Zone Directors, Unit Leaders and members, and that will facilitate interaction between different units.


#### **Outstanding Auxiliarists Recognised**

# Coming Soon: ISAR 2003

The fourth annual International Search and Rescue Competition is gearing up to be a great event. ISAR 2003 will be held in St. John's, Newfoundland on September 26 and 27, 2003. The venue of events will be the Canadian Coast Guard Base on Friday and the Royal Newfoundland Yacht Club (RNYC) in Conception Bay South on Saturday. An awards banquet at the Delta St. John's Hotel and Convention Center on Saturday evening will top off the two-day event.

ISAR is a friendly competition between representatives of the United States Coast Guard Auxiliary and the Canadian Coast Guard Auxiliary. It is an opportunity for Auxiliarists from around the continent to showcase their skills, learn from each other and make new friends. ISAR is a symbol of the growing friendship between the USCGA and the CCGA.

Each Auxiliary is represented by 6 teams of 4 members. Three team members will compete together in the following 6 events: Search and Rescue Planning, On-Water SAREX, SAR Pump, Heaving Line 1, Heaving Line 2, and a mystery event. As at ISAR 2002, the fourth team member, who will be chosen at random by the event organizers on September 25, 2003, will join one of 4 International teams. These teams will compete in separate events where individuals can earn points that will be transferred to their region team's score. The events for this group are Chartwork, Marlinspike, Water Rescue, Heaving Line 3, and a mystery event. All events will be presided over by 2 judges, one from the Canadian Coast Guard and one from the USCGA.

In addition to the competition, several different SAR attractions will be present at the event. These include the Canadian Coast Guard Ship Sir Wilfred Grenfell, a T600 high-endurance offshore SAR cutter, the CCGA Vessel "Roberts Sisters II", and a Cormorant SAR

# Minister McCallum Approves New Search and Rescue Initiatives

The Honourable John McCallum, Minister of National Defence and Lead Minister for Search and Rescue, has approved search and rescue projects for 2003-2004. The projects will be funded from the New Search and Rescue Initiatives Fund, managed by the National Search and Rescue Secretariat.

The Fund improves search and rescue efforts through state-of-the-art equipment, technology, research, prevention programs and training. With an annual budget of \$8.1 million, the Fund supports search and rescue projects that enhance air, marine and ground search and rescue activities in Canada. Since 1988, \$120 million has been invested in over 700 projects.

Thanks to this year's NIF Program, CCGA Pacific wll benefit from a grant of \$142,890 over a three year period to implement a SAR prevention program targeted at children. The prevention program will use "Bobbie the Safety Boat", an animatronic remote controlled robot designed to assist boating safety educators in capturing the attention of children. Volunteer members of the Canadian Coast Guard Auxiliary (Pacific Region) will present the program to children at schools, hospitals and boat shows.

### **Digital Selective Calling**

#### A New Era In Maritime Communications

n February 1, 1999, a new style of communicating between and among ships, boats, and coast stations around the world, the Global Maritime Distress and Safety System (GMDSS), officially came into being. Many Auxiliary members think that such matters are the concern of the "big boys", the tankers and merchant ships, the passenger liners and cruise ships. They believe that because most of our activity is centered around recreational boaters and vessels, the GMDSS is not of concern to us. A division of the United States Coast Guard Auxiliary recognised that this is not true and undertook a project to evaluate one of the new technologies, Digital Selective Calling (DSC).

Many Auxiliary members think that such matters are the concern of the "big boys"...

The big difference between a DSC radio and a regular radio is that the DSC radio contains a unique number, called a Maritime Mobile Service Identity (MMSI), that identifies the vessel the radio is associated with. The result is that with a DSC radio, if you send certain kinds of messages like distress messages, whoever receives the message knows which vessel sent the message, without your identifying yourself by voice. Further, DSC radios can be hooked up to your GPS and automatically tell a listener not only who you are, but where you are. A third feature allows two vessels, each with a DSC radio, to send a message from one radio

to the other radio and have the second radio respond by sounding an audible alert and automatically switching to a channel picked by the first vessel.

Through the cooperation of two radio manufacturers, the willingness of three vessel owners to offer their vessels as test beds, and the commander and crew of Station Los Angeles, USCGA Division 3 of 11 Southern Region was able to conduct a real life, on the water test of this new technology.

Three tests were completed during the exercise. First was a periodic interrogation of each vessels DSC that was maintained for a period of about 1 hour and clearly demonstrated the effectiveness of the DSC tool as a tracking device.

The second test involved one vessel using his DSC radio to interrogate the radio of another vessel in order to retrieve the location of the second vessel without any voice communications.

The final test determined that this form of data transmission was effective at gathering position information from vessels in areas that are notorious for their difficulty in maintaining voice comms with Station LA.

All aspects of the test were completed to the satisfaction of those involved. The test illustrates the many possibilities available for the use of DSC in auxiliary operations primarily as a safety tool but with other applications as well. DSC will be a major safety enhancement, but only if the boating public understands how to use it, and the auxiliary understands how to integrate it into the maritime communications world.

### **Blue Flashing Light**

#### Changes to Regulations Affect CCGA Vessels

n January 30, 2003 Canadian Coast Guard Auxiliary vessels were extended permission to exhibit the Blue Flashing Light during SAR operations, as per Rule 45 of the Collision Regulations.

Rule 45 allows a 'government ship' to exhibit as an identification signal a blue flashing light when providing assistance in a search and rescue operation or when engaged in law enforcement activities. The amendment to this Rule allows CCGA vessels to also exhibit the blue flashing light while engaged in SAR activities.

Rule 45 was amended in response to a request from the CCGA that was fully supported by the Canadian Coast Guard. The CCG felt that the number of SAR incidents to which CCGA vessels respond (approximately 1700 each year) supports and justifies the use of the blue flashing light by CCGA vessels.

Use of the blue flashing light by the CCGA will identify CCGA vessels to other vessel and aircraft operators during SAR operations. It is particularly important during night operations and during searches in poor weather conditions. This issue has arisen on numerous occasions when the distressed vessel had difficulty identifying the CCGA vessel. In addition, other search vessels or aircraft have also had difficulty identifying a CCGA vessel as a search and rescue vessel. This is especially important when an aircraft wants to direct a CCGA vessel towards a stricken vessel.

### **Guidelines on Use of Blue Flashing Light by CCGA Vessels**

- Strict adherence to the proper use of the blue flashing light is essential.
   CCGA vessels are only permitted to exhibit the blue flashing light during authorized response to SAR incidents when tasked by the Joint Rescue
   Co-ordination Centre/Maritime Rescue
   Sub-Centre.
- CCGA vessels shall only exhibit the light when the CCGA vessel needs to identify itself while providing assistance to any vessel or other craft, aircraft or person that is threatened by grave and imminent danger and requires immediate assistance.
- CCGA vessels shall only exhibit the light at or near the scene of the SAR incident.
- The blue flashing light is NOT to be exhibited during transit to and from an incident.
- The blue flashing light is NOT a towing light.
- CCGA Vessels no longer involved in SAR operations shall not exhibit the blue flashing light
- It should be noted that the blue flashing light provides no special privileges with respect to rules of the road.

#### The CCGA Attends CSAR 2002

The Canadian Coast Guard Auxiliary was among the 70 representatives from 22 countries to attend the Caribbean Volunteer Maritime SAR Conference (CSAR) in Miami on December 5-8, 2002. The United States Coast Guard Auxiliary hosted the Conference at the Hyatt Regency Hotel in Downtown Miami.

According to Commodore Everette Tucker, past National Commodore and Director of International Affairs of the USCGA, one of the main objectives of the conference was to "enhance the ability and capability of the nations in the Caribbean to provide safety at sea services."

In support of this goal, representatives of almost all Caribbean nations were invited to send a representative of their Navy, Coast Guard or police force to the conference. As well, a representative of the country's volunteer search and rescue association or if no such

The conference topics included the establishment of volunteer SAR organisations, the development and expansion of the capability to conduct SAR operations and the improvement of SAR control and coordination.

Representatives from the Netherlands, the United Kingdom, Venezuela and several international Maritime organizations attended the event, in addition to the United States and the Caribbean Countries. Since the conference, 2 Caribbean countries have started their own volunteer maritime rescue service.

### **Blue Flashing Light**

- The blue flashing light is also used as an identification signal by Canadian and United States law enforcement ships when engaged on law enforcement duties. Any misuse of the blue flashing light will not only detract from its effectiveness both as a safety and an enforcement identification signal, but may create confusion, distract vessels or have other serious consequences. Since in the United States, the blue flashing light is only permitted to be exhibited by law enforcement vessels, proper use by CCGA vessels in boundary waters is particularly important.
- Canadian Coast Guard Auxiliary vessels are not required to outfit their vessels with a blue flashing light. Installation of the light by CCGA vessels is strictly voluntary and contribution funds are not to be used to purchase these for members' vessels.
- The change to the regulations will facilitate the identification of CCGA vessels and help auxiliarists carry out SAR operations more effectively.
- Penalties for contravening the Collision Regulations are prescribed in the Canada Shipping Act with fines of up to \$2,000 for vessels up to 20m in length.

### **CCGA Activities On Inland Waters**

s requested at the CCGA National Council Meeting on October 3, 2002, in Milwaukee, Wisconsin, the following provides clarification on CCGA activities on inland waters as detailed in the CCGA National Guidelines.

CCGA SAR Operations—CCGA SAR Operations are restricted to operations only on those waters under the federal area of maritime SAR responsibility of the CCG. The Auxiliary is normally not authorized to participate in SAR Operations outside federal areas of responsibility, namely, inland waters.

CCGA SAR Prevention—The Auxiliary is permitted to participate in authorized SAR Prevention and boating safety activities anywhere in Canada. Participation in authorized SAR Prevention and boating safety activities must be pre-approved by the CCG.

However, in order to eliminate confusion by the general public and to avoid mission creep of SAR Operations, the Auxiliary is not authorized to use vessels on these inland waters for which the CCG has not accepted responsibility in support of SAR Prevention and boating safety activities. The CCG will not authorize the use of CCGA vessels to deliver SAR Prevention and boating safety activities while at sea or underway. Since this is not an authorized activity, CCGA members and their vessels would not be covered by the CCGA insurance policies.

For clarification purposes, the context of this memo inland waters are those waters that are outside the normal federal area of accepted responsibility for maritime SAR. Inland waters are mainly those waters within the territorial limits of the provinces and territories where the responsibility for SAR Operations falls under the jurisdiction of the provincial or territorial government.

ave an idea on how to make our search and rescue system better? You should consider making a proposal to the New SAR Initiatives Fund (NIF) through your regional CCGA Association. Every year, this fund allocates \$8.1 million to support new ideas to improve Search and Rescue prevention and response in Canada. Since 1988, the NIF has funded 700 projects totalling over \$120 million.

The Canadian Coast Guard recently added a NIF page to its Web site (www.ccg-gcc.gc.ca/sar/NIF/nif\_e.htm) to provide in-depth information on what the NIF fund has achieved for SAR in Canada.

Among other things, the page describes current and completed projects, as well as proposals from past years. Please look at these Web pages to ensure that your proposal is not too similar to a project that has previously been submitted. As well, you must discuss your idea with HQ SAR office before writing a full proposal.

The NIF page also allows you to share your plans in the "Ideas" section, if you do not have the time or resources to carry out the project yourself. This way, others may be inspired to make your plan a reality.

Proposals for 2004-2005 are being accepted until the last Friday in June (June 27, 2003). No proposals for the 2004-2005 year will be accepted after that date.



The Canadian Coast Guard Auxiliary is proud to present you with our Annual Report of activities for the year 2002.

This past year has kept the volunteers of the CCGA very busy with 2,120 taskings to search and rescue incidents.

With 4,988 members and 1,410 vessels (value of the Auxiliary fleet is \$280 million), the resources made available to the Canadian Coast Guard are considerable and the contribution significant.

Our Safe Boating officers also had a very productive year. The CCGA was present at 492 boat shows and public displays and 3,125 courtesy checks were performed on private vessels.









### CCGA Vessels 2002





### CCGA Taskings 2002







- 4) As soon as the surveyor's report is completed, we will issue you a tax receipt for the appraised value of your vessel and confirm your Benefactor Membership with the Canadian Coast Guard Auxiliary.
- 5) Once the transfer of ownership is completed, the CCGA will take full responsibility and

assume all costs for moorage, storage, transport, maintenance and insurance for the vessel.

After many years of reliable service to you, there can be no greater reward than to know that your vessel will remain active, assist in saving lives and make boating safer for yet another generation of mariners in Canada.
